Invitation to scoping consultation for Humletorp wind farm

Eolus Vind AB and Hydro REIN ("Eolus" and "Hydro") are investigating the possibility to build and operate a wind farm at Humletorp in the municipality of Årjäng through a joint company, Förnybar by Eolus Hydro Rein AB ("Förnybar"). The wind farm is intended to include up to 12 wind turbines with a maximum total height of 300 metres. Eolus and Hydro plan to apply for a permit under the Environmental Code for the planned operations through Förnybar.

Before the permit application is prepared, a consultation is carried out in accordance with Chapter 6 of the Environmental Code. Property owners, tenants and other rights holders within three kilometres of the project area (see map below) have been considered likely to be particularly affected by the activity. The activity may entail environmental impact such as noise, visual impact, etc.

You are invited to the consultation as a person who is likely to be particularly affected by the activity. If you are the owner of a property within/near the project area, please forward this invitation as soon as possible to any rights holders within your property. The consultation invitation will also be sent to authorities, local associations and organisations. Information about the consultation has also been advertised in local newspapers.

You now have the opportunity to submit comments and information in order to influence the work on the permit application and the environmental impact assessment that will be included in the permit application.
